RESOLUTION NO. 17-22

A RESOLUTION ESTABLISHING FEES AND RATES FOR SOLID WASTE COLLECTION SERVICE IN THE CITY OF LAS ANIMAS

WHEREAS, for the peace, health, safety and welfare of the citizens of Las Animas (the "City"), it is deemed necessary for the City to provide Solid Waste Collection service to its citizens; and

WHEREAS, such Solid Waste Collection services includes both scheduled and non-scheduled garbage, refuse and trash pickup and disposal; and

WHEREAS, because of increases in cost in private landfill disposal of solid waste and the increases in cost for gas and labor costs it is necessary to raise solid waste collection rates to cover cost; and

WHEREAS, it is necessary for each and every citizen and customer of the City pay a fair and equitable share of the cost of this Solid Waste Collection service; and

WHEREAS, the City Council has conducted a public hearing to consider evidence and testimony on the increases in the Solid Waste Collection services rates and charges thus providing adequate opportunity for interested residents and customers to be heard.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAS ANIMAS, COLORADO, THAT:

Section 1. The above recitals are incorporated by reference.

Solid Waste Collection service rates are hereby established, of which said rates shall supersede and replace all of those rates set out in Resolutions previously considered, as follows:

1. SERVICE TO DWELLINGS AND BUSINESSES.

- a. Dwellings shall include all single family residences, duplexes, or two family dwellings. Fees for dwellings shall be \$23.75 per month per dwelling.
- b. Multiple family dwellings shall be all residential buildings, except hotels or motels, having three (3) or more separate living units. Fees for multiple family dwellings shall be \$23.75 per month for each living unit
- c. Commercial #1 Business sharing dumpster with another business or a residence shall be charged \$35.65 per month
- d. Commercial #3 -Business with one 3 yard dumpster shall be charged \$60.65 per

month.

- e. If any business or dwelling requests its own dumpster or another dumpster the fee shall be \$60.65 per month.
- f. For services outside the City Limits, see attached rate breakdown sheet.
- 2. SERVICE FOR ROLL-OFF RENTAL.
 - a. The roll-off base rental fees are presented in the attached rate breakdown sheet.
- 3. Transfer Station fees. In addition to the base rates provided herein above, special fees shall be charged in those cases where the Public Works Department personnel shall be required to collect such items as refrigerators, stoves, furniture, etc., and large accumulations of trash or metal. In addition, trash placed by dumpster will also be subject to an additional charge.

Transfer Station fees are presented in the attached rate breakdown sheet:

- 4. SPECIAL CONDITIONS. Any special conditions not included in the above rate schedule shall be determined by the Director of Public Works, subject to the approval of the City Council.
- 5. CITY AND COUNTY PROVIDED SERVICE RATES (OUTSIDE CITY LIMITS).

These services covered under the City and County Provided Service Rates include the following: Outside City Limits Private 3-yard dumpsters; Roll-off Rental rates; Transfer Station rates.

- <u>Section 3.</u> <u>Extraterritorial Rates Conditionally Approved.</u> Rates for services outside the municipal boundaries of the City are approved conditionally subject to approval by the County Commissioners for Bent County.
 - Section 4. Previous Resolution Repealed. Resolution No 13-14 is repealed in its entirety.
- Section 5. Savings Clause. All other Solid Waste Collection rates not in contradiction with those rates set forth herein shall remain the same as previously adopted by the Las Animas City Council.
- Section 6. Effective Date. This Resolution and the recommended rate schedule for services only provided by the City shall become effective for September 1, 2022 billing cycle, due and payable after October 15, 2022. The recommended date schedule for services provided by both the City and the County shall become effective the month following the County approval, which will be due and payable the 15th of the month after the effective date.
